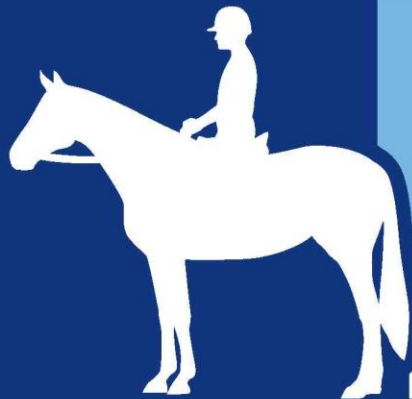

Levels:	USDF Introductory through FEI Grand Prix, including Open, Junior/Young Rider, Adult Amateur, as well as Opportunity Classes.
Entries:	<p>Online Entries ONLY at https://entry.foxvillage.com/</p> <p>Accepted on a first-come, first-serve basis. One entry per horse/rider combination. Completed entries (signature pages, copies of all association cards, and a copy of a current Coggins within 12 months of show date (with horse's show name – per USEF rule GR906.4) and a copy of horse's vaccination records within 6 months of show date (per USEF rule GR844)) must be with entry or be emailed to the competition secretary at dressageshowsec@aol.com.</p> <p>USEF and USDF non-membership fee(s) are not required for Opportunity Classes.</p> <p>Horses are limited to a maximum of three dressage rides per day at Fourth Level and below two dressage rides per day above Fourth Level. Horses competing at both Fourth Level and Prix St. Georges, or their equivalents, are limited to two dressage rides per day. Horses may enter no more than two consecutive levels, Freestyle levels included, at any one competition. Dressage Seat Equitation, Quadrille, Pas de Deux and Materiale classes are excluded from the maximum limit of rides per day and horses in these classes may compete at any level for which they are otherwise eligible during the same competition. See USEF Rule DR119.2.</p>
Awards:	<p>Divisions (Junior/Young, Adult Amateur, Open) will be run concurrently as one class and pinned separately. Riders must clearly specify their division choice. When no designation is made, riders will automatically be entered as OPEN – exhibitors enter with this understanding and agreement. Riders may enter only one division per class.</p> <p>High Point Ribbon and Overall High Percentage for the Show:</p> <p>Ribbons through 6th place will be awarded in all classes. When divisions have less than (3) entries, show management reserves the right to combine divisions and pin them as one class. Show management also reserves the right to split classes or cancel classes as entries warrant.</p> <p>Overall High Percentage – Champion ribbon in all three divisions (Open, AA, JR/YR), across all levels.</p> <p>USDF opportunity classes, materiale tests, young horse classes, equitation, and musical freestyles are not eligible for the champion ribbon.</p> <p>Ribbons/Awards will not be mailed . . . competitors must pick-up awards before leaving the show.</p>
Pony Measurement:	Please contact the secretary prior to the closing date to set an appointment for a measurement with the show veterinarian and technical delegate. A measurement fee of \$100 must be paid on entry. The measurement must take place prior to first pony test ride.
Sharps Containers:	Sharps containers will be placed in each stabling aisle. Per USEF Rule GR1210.4, Competition Management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments.
Non-competing horses:	\$100 for the weekend – for horses not competing in the show. Must fill out entry form for number and pay office fee, along with stabling. No USEF/USDF fees need to be paid.
Confirmation of Entry:	Confirmation of entry will be e-mailed to the rider. All e-mail addresses must be clearly printed. Make sure you turn off your spam filter for Fox Village.
Definitions:	<p>Adult Amateur (AA) = Individuals possessing current amateur certification are only eligible as Adult Amateurs from the beginning of the calendar year in which they reach age 22. USEF rule DR119.3. Only active United States Equestrian Federation members may obtain amateur status. (Exception: Equine Canada members in possession of current EC membership may sign for USEF Amateur status on a show-by-show basis at no cost). Participants must possess current USEF Amateur status and qualify under the USEF Amateur rules. If opportunity classes at Dressage Competitions are restricted to amateurs, riders are required to have an amateur status with USEF. See GR821.</p> <p>Junior/Young Rider (JR/YR) = Open to Junior & Young Riders only. Individuals are eligible as JR's until the end of the calendar year in which they reach the age of 18. Individuals are eligible as YR's from the beginning of the calendar year in which they reach age 16 until the end of the calendar year in which they reach the age 21. See USEF rule DR119.3.</p>

Late Entries:	\$45 – if received after the closing date.
Post Class Entries:	\$10 plus normal class fee – Post class entries accepted ONLY if time allows by 3:00PM the day before.
Returned Check Fee:	\$50 for checks returned due to non-negotiable funds.
Great American/ USDF Qualifying Classes:	<p>Please indicate that the class is to count for qualifying by placing a Q after the class number. Qualifying will not require a separate ride. An exhibitor riding in the Open, Adult Amateur or Junior/Young rider classes will pay an additional \$15 USDF qualifying fee (must be paid prior to start of the class) to have the score entered in the Great American/USDF qualifying division at that level. Qualifying classes count towards the 2024 Great American/USDF Regional Championships.</p> <p>Check the www.usdf.org for qualifying dates, score requirements and locations of championships.</p>
Payment:	<p>Payment is due at the time entries are submitted to show management in US funds. This competition accepts payment via a credit card on Fox Village, and either Venmo (@majestic5700), check or cash at the show. Please contact the show secretary with any questions.</p> <p>Online entries <u>ONLY</u> at https://entry.foxvillage.com/ with a credit card.</p>
Entry Cancellation and Refunds:	<p>Cancellations only in writing either by mail or e-mail prior to or on the closing date. 100% of entry fees will be refunded with veterinarian or doctor's certificate before closing date, minus the office fee.</p> <p>NO REFUNDS, including stall and office fees, for any reason after the OFFICIAL PUBLISHED closing date, even if the closing date is extended. Every effort will be made to refund entries via the original method of payment. SEE USEF rule GR910 for substitution of rider.</p>
No Shows:	All "No Shows" that have not contacted the show office, prior to their first ride, will be considered a scratch for the rest of the show and time slots may be filled. Exhibitors enter with this understanding and agreement.
Ride Times:	<p>Unofficial ride times will be posted to www.foxvillage.com after 6:00 PM on Tuesday, April 30th. It is the responsibility of the rider to inform show management of any time conflicts as soon as possible after receiving the unofficial ride times. Please DO NOT call for your ride times. Official ride times will be posted in the show office by NOON the day before the competition starts.</p>
Arenas/Footing:	All outdoor rings (both warm-up arenas and competition rings) are sand all weather 60m x 20m, or 40m x 20m (as needed). Designated lunging area with sand all weather footing.

Opportunity Classes:	<p>Open to those new to showing dressage. Horses and riders competing in “opportunity” classes are exempt from USEF and USDF membership requirements, and do not have to pay non-member or horse identification number (HID) fees or USEF drug fees. “Opportunity” riders/horses will be allowed to cross-enter other recognized classes at the show but must pay all applicable USEF and USDF fees.</p> <p>Opportunity classes follow all USEF Dressage Division rules and applicable USEF general rules, including dressage and saddlery, and are subject to drug testing. Opportunity classes cannot be used as qualifying classes for the Great American/USDF Regional Championships. See GR821.</p>
Stabling:	<p>Permanent box stalls with doors are 12 x 12 stalls Barn C, 10 X 10 stalls in Barns D – G all with full doors. Stalls are available on a first come, first serve basis by entries received by date. All horses must have a stall. No initial bedding provided and should be included on your entry form or order from show office by 3:00 PM each day. No guarantees of same day delivery if ordered after 3:00 PM. Please specify barn of choice on entry form. Competitors are responsible for all stall damage. ABSOLUTELY NO NAILS, SCREW EYES IN METAL OR WOOD. Every effort is made to honor stabling requests but cannot guarantee. When asking to be “stabled with” someone please designate one Name for your group in the “stable with” section of the entry form.</p> <p>Stall changes must be approved by the show office. Horses found in an incorrect stall may be moved and fined \$50.00. This is for safety issues. Stallion owners need to bring suitable equipment to close off the stall, if necessary, for the safety of your horse and those stabled near him.</p> <p>Stalls will be available after 12 PM on FRIDAY. Early arrivals and late departures must be approved by show management and may be assessed additional stabling fees.</p> <p>SMOKING IS PROHIBITED IN STALL AREAS.</p>
Weather/Acts of God/Accidents or Emergency Policy:	<p>Management reserves the right to cancel any classes due to hazardous weather, acts of God, accidents or emergencies. Every effort will be made to reschedule with priority given to any Championship or qualifying classes being offered. No refunds for cancellations due to hazardous weather, acts of God, accidents, or emergencies. See GR.311.</p> <p>During inclement weather, for safety and social distancing, participants will be asked to shelter in their personal vehicles or in their tack stall. Participants will not be allowed to congregate in the concession stand or the show office.</p>
Camper/RV Hook-up:	<p>\$150 per weekend – Camping will be assigned on a “first come, first serve” based upon receipt of entry. Available after 12PM on Friday thru Sunday at 9PM.</p>
Medical:	<p>Medical personnel will be on grounds. Ambulance on call.</p>

Food:	<p>Will be available on the show grounds during normal show hours.</p>
Warning:	<p>Under the Equine Activity Liability Act, each participant who participates in an equine activity expressly assumes the risks of engaging in and legal responsibility for injury, loss, or damage to person or property resulting from the risk of equine activities.</p>
Other:	<p>Per USEF rule (GR1301.6): Dogs are not permitted to be loose on competition grounds and must be on a leash (not to exceed 6 feet in length) or otherwise contained (in a tack stall/cage etc.). Individuals must not lead dogs on a leash while mounted. Dog owners failing to comply with this rule may be subject to penalties by USEF, as well as warning cards. Loose animals or animal’s left in vehicles in distress, etc., can and will be removed, from the grounds at the owner’s expense.</p>
Protective Headgear:	<p>From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on a horse at any time on the competition grounds, including non-competing riders, riders on non-competing horses, and those competing in all classes and tests, including Para-Equestrian tests, must wear protective headgear as defined by this rule and otherwise in compliance with GR801. Any rider violating this rule at any time must immediately be prohibited from further riding until such headgear is properly in place. See USEF Rule DR121.1.</p>

Freestyle Entries:	<p>Per USEF Rule DR129.9: Except for USEF/USDF Championship classes and for FEI Pony Riders, FEI Junior and FEI Young Rider Freestyles, in order to enter a freestyle class at any level, a horse/rider combination must have received a minimum score of 63% for Training through Fourth levels and 60% for FEI levels in the highest test of the declared freestyle level or any test of a higher level at a Federation /USDF Licensed Dressage Competition or FEI recognized Dressage Competition or “open” Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. To enter an FEI Para Dressage Freestyle class, a horse/rider combination must have received a minimum score of 60% in any FEI Para Dressage test (Para Novice Test, Para Intermediate Test or Para Grand Prix Test) at the rider’s classified Grade. This score may be earned at a USEF/USDF licensed Dressage Competition or FEI recognized Dressage Competition or “open” Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. A photocopy of the test verifying eligibility, or copy of the USDF score verification, must be submitted with the entry for a freestyle class. All FEI Pony Rider Tests are equivalent to Second Level; all FEI Junior Tests are equivalent to Third Level; all FEI Young Rider Tests are equivalent to PSG; and the USEF Brentina Cup (Young Adult) Test and FEI Young Rider Grand Prix 16-25 Tests are equivalent to Intermediate II. For purposes of freestyle qualification, all are considered equivalent to the highest test of that level and may be used to enter a freestyle at that level or a level below. Young Horse and FEI Children Tests cannot be used for freestyle qualification at any level.</p> <p>The music must be a MP3 file and emailed to mainoffice@majesticfarm.net. The schedule for sound checks will be posted at the show.</p>

Directions:	<p>From Dayton, OH 75 South to 275 East to Exit 59, Milford Parkway From Columbus, OH 71 South to 275 East to Exit 59, Milford Parkway From Lexington, KY 75 North to 275 East to Exit 59A, Milford Parkway From Louisville, KY 71 North to 75 North to 275 East to Exit 59A, Milford Parkway</p> <p>From Exit 59a, follow Milford Parkway towards and past the Showcase Cinemas, Target. At the first light before Target, continue on Milford Parkway. At your second light, you will be at US 50, cross US 50. This then becomes East State Route 131. Go approximately 6.2 miles (four lights) to the intersection of State Route 131 and State Route 132 (Williams Corner). At light, take a right and head South on State Route 132 approximately 8/10 of a mile. Majestic Farm is on your left.</p>
USEF Show Pass:	<p>Effective 12-1-2022 any rider, handler, driver, or owner are limited to one Show Pass purchase annually (December 1-November 30). A USEF Show Pass will be available for purchase by exhibitors on-line only, within 7 days of the show’s start date. Competitions will not accept payment for show pass fees and therefore this fee will not appear on the entry blank. Individuals, including parents who are signing as trainer on behalf of a minor, who are participating as a trainer or coach are not eligible for a Show Pass and must obtain a Senior Competing membership to participate in a USEF-licensed competition.</p>
Prize Giving/Award Ceremonies:	<p>Per USEF Rule DR123.13, “Participation in prize-giving (awards) ceremonies by placed rider/horse combinations may be mandatory and failure to participate may result in loss of prizes and prize money at the discretion of Competition Management. Specific requirements and penalties for failure to participate in prize-giving ceremonies must be announced in the prize list.” This show does NOT require a prize giving/awards ceremony; therefore, it is not mandatory for placed riders to attend. Awards/ribbons will be given to competitors at the end of each class, and as such, they can be picked up in the show office.</p>
Vendors:	<p>ALL vendors, including braiders, food services, retail, etc., must have insurance if they will be on the property. A copy must be on file in the show office. Contact Majestic Farms with any questions.</p>

Minors who have a valid temporary license may operate the above-described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of individual members and over 100 independent organizations throughout the United States, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

- a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.
- or
- b) Qualified to compete in any regional dressage championship class (excluding freestyles).

Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

2024 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at www.usdf.org. Please refer to the 2024 USDF Member Guide for the comprehensive list of rules and requirements for this program.

Membership/Registration Requirements for Qualifying and Championships

All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.

Rider:

- Must have a USDF Participating* Membership (PM).
- Must have a USEF membership (Active or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s).
A horse is not required to have breed registry papers.

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual or Life Recorded Farm/Business). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

Minimum Qualifying Scores: One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division.

Membership Requirements for USEF-licensed/USDF-recognized Competitions: Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

Memberships Defined

Participating Membership (PM): A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$90), 5-years (\$360), or life (\$1,800). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$72). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

Group Membership (GM): A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program.

Business Membership (BM): A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$240) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

Non-Member (NM) Identification Number: For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$35 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

Horse Identification (HID) Number: A one-time tracking number for horses (\$35). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$80. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

Lifetime Horse Registration (LHR): A horse with an LHR (\$115) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

Applications for USDF Participating Membership (PM), Business Membership (BM), Horse Identification (HID) number, and Lifetime Horse Registration (LHR) may be found in the following locations:

USEF Equine Vaccination Rule

From the USEF Communications Department

Lexington, Ky. - In January, the USEF Board of Directors approved an addition to the rule book, which outlines equine vaccination requirements at licensed competitions. Beginning December 1, 2015, all horses entering the grounds of a Federation-licensed competition must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables.

Due to several high profile Equine Herpes (EHV) outbreaks in recent years that have involved the neuropathic strain of the virus (equine herpesvirus myeloencephalopathy-EHM), some competitions have placed vaccination requirements on their competitors that go beyond most accepted medical opinions and raise concern that unnecessary requirements can potentially put a horse at risk. The intent of this rule is to ensure that all licensed competitions comply with the vaccination guidelines for Equine Influenza and Equine Herpes (Rhinopneumonitis) published by the American Association of Equine Practitioners (AAEP). These guidelines are reviewed by infectious disease experts regularly, and recommend vaccinating competition horses at six-month intervals for both equine influenza (flu) and rhinopneumonitis (EHV-1 and EHV-4). There is not a vaccine that protects against EHM.

Intended to promote proper vaccination protocols, this rule does not anticipate an increased workload for competition management. The flu vaccination information can be added to the documentation already required by most competitions: a horse's health certificate and a negative coggins test.

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

For and in consideration of United States Equestrian Federation, Inc. dba US Equestrian ("USEF") allowing me, the undersigned, to participate in any capacity (including as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, official, trainer or volunteer) in a USEF sanctioned, licensed or approved event or activity, including but not limited to equestrian clinics, practices, shows, competitions and related or incidental activities and _____ ("USEF Event" or "USEF Events"); I, for myself, and on behalf of my spouse, children, heirs and next of kin, and any legal and personal representatives, executors, administrators, successors, and assigns, hereby agree to and make the following contractual representations pursuant to this Agreement (the "Agreement"):

A. RULES AND REGULATIONS: I hereby agree to be bound and abide by the rules, regulations, and policies of USEF as published in the USEF Rule Book and on the website at www.usef.org, as amended from time to time.

B. ACKNOWLEDGMENT OF RISK: I knowingly, willingly, and voluntarily acknowledge the inherent risks associated with the sport of equestrian and know that horseback riding and related equestrian activities are inherently dangerous, and that participation in any USEF Event involves inherent risks and dangers. "Inherent risk of an equine activity" means a danger or condition that is an integral part of an equine activity, including, but not limited to, any of the following: (a) The propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine; (b) The unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals; (c) Hazards, including, but not limited to, surface or subsurface conditions; (d) A collision with another equine, another animal, a person, or an object; (e) The potential of an equine activity participant to act in a negligent manner that may contribute to injury, death, or loss to the person of the participant or to other persons, including, but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant; (f) the potential for serious bodily injury (including broken bones, head or neck injuries), sickness and disease (including communicable diseases), trauma, pain & suffering, permanent disability, paralysis and death; (g) loss of or damage to personal property (including my mount & equipment) arising out of the unpredictable behavior of horses; (h) exposure to extreme conditions and circumstances; accidents involving other participants, event staff, volunteers or spectators; (i) contact or collision with other participants and horses, natural or manmade objects; (j) adverse weather conditions; (k) facilities issues and premises conditions; (l) failure of protective equipment (including helmets); (m) inadequate safety measures; (n) participants of varying skill levels; (o) situations beyond the immediate control of the USEF Event organizers and competition management; and (p) other undefined, not readily foreseeable and presently unknown risks and dangers ("Risks").

EQUINE ACTIVITY LIABILITY ACT WARNING:

C. ASSUMPTION OF RISK: I understand that the aforementioned Risks may be caused in whole or in part or result directly or indirectly from the negligence of my own actions or inactions, the actions or inactions of others participating in the USEF Events, or the negligent acts or omissions of the Released Parties defined below, and I hereby voluntarily and knowingly assume all such Risks and responsibility for any damages, liabilities, losses, or expenses that I incur as a result of my participation in any USEF Events. I also agree to be responsible for any injury or damage caused by me, my horse, my employees or contractors under my direction and control at any USEF Event.

D. WAIVER AND RELEASE OF LIABILITY, HOLD HARMLESS AND INDEMNITY: In conjunction with my participation in any USEF Event, I hereby release, waive and covenant not to sue, and further agree to indemnify, defend and hold harmless the following parties: USEF, USEF Recognized Affiliate Associations, the United States Olympic & Paralympic Committee (USOPC), USEF clubs, members, Event participants (including athletes/riders, coaches, trainers, judges/officials, and other personnel), the Event owner, licensee, and competition managers; the promoters, sponsors, or advertisers of any USEF Event; any charity or other beneficiary which may benefit from the USEF Event; the owners, managers, or lessors of any facilities or premises where a USEF Event may be held; and all directors, officers, employees, agents, contractors, and volunteers of any of the aforementioned parties (**Individually and Collectively, the "Released Parties" or "Event Organizers"**), with respect to any liability, claim(s), demand(s), cause(s) of action, damage(s), loss, or expense (including court costs and reasonable attorney fees) of any kind or nature ("**Liability**") which may arise out of, result from, or relate in any way to my participation in the USEF Events, including claims for Liability caused in whole or in part by the negligent acts or omissions of the Released Parties.

E.
